2020/78 Apologies for Absence

Apologies were received from Councillors Field and Hemamda

2020/79 Declarations of Interest

- (a) Councillor Butler declared an interest in Agenda Item 14 Planning Applications in respect of the property at 75A High Street

2020/85 Matters arising from the minutes of the meeting held on 30th April 2020

A discussion took place as to how to proceed with the Planning appeal. It was agreed that Deirdre Wells of Red Kite be instructed to act on behalf of the Parish Council in preparing, presenting and being cross-examined on the statement to be made at the inquiry. It is to be requested that it be made clear that the Council would require Deirdre to appear at the inquiry and nobody else.

It was mentioned that the clerk had had no success in engaging with further Consultants and therefore no comparative quotations could be obtained.

It was discussed as to how to proceed with the Planning Appeal. It was proposed by Councillor Jenkins, seconded by Councillor Atkinson, agreed unanimously and

RESOLVED

that a working party consisting of all councillors and any members of the public who may be able to assist be invited to take part be formed. Decision making regarding the work involved in the planning appeal would be delegated to the clerk in consultation with the working party who would report back to Council.

It was suggested that Robin Draper and Tom Duckett be asked to be part of the working committee.

A request to be made in the Sutton Courtenay News and on the Council website that should anyone have further comments which may assist to contact the Clerk in the first instance.

2020/86 Matters raised by Councillors for information

Councillor Atkinson confirmed that she believed the date for which Section 106 monies were required to be spent was being extended due to the Coronovirus outbreak. The clerk is to write to the Vale of the White Horse District Council to request confirmation of the same.

Councillor Lazare raised the issue of the potential need for non-medical facemasks. The clerk is to ask anybody currently making/willing to make them to email to confirm the situation. Councillor Webber may be able to fund the purchase of material to make the facemasks with some of the emergency funds he holds.

Councillor Lazare also raised the issue of promoting the Neighbourhood Watch in the area. The clerk is to add the link to the Facebook Group into the Sutton Courtenay Newsletter article and onto the website.

Councillor Corrigan raised the issue in the rise of Domestic violence during this period. The clerk is to add the contact details of support groups to the website.

Councillor Corrigan also suggested that it may be nice for the village to come together to make something similar to the "scarecrow trail" possibly using the theme "thank you" to make anybody walking through the village as part of their daily exercise have something to look for. The clerk is to contact Guides, Scouts, the Church and Damascus Youth who may be interested in taking part and coordinating the same. Councillors to contact the Clerk with any other groups who also be interested in taking part.

Councillor Corrigan also requested that the clerk mention in the Sutton Courtenay news and on the website that the speed limit through most of the village was 30mph.

Councillor Butler raised the issue of the use of footpaths around "the Pools". This will be discussed further under the correspondence section of the agenda.

Councillor Butler also requested that a reminder be put into the Sutton Courtenay News and on the website requesting that dog owners pick up their dogs waste and dispose of appropriately.

P20/V0664/LDP – turning carport into hallway and additional room and formation of new window opening on north elevation 27 The Nursery

P20/V0521/LDP – loft conversion including rear dormer and front roof windows 89 Bradstocks Way

The clerk is to refer any further applications to the Council at the meeting or the Planning Committee in the usual way, depending on the decision date.

Councillor Atkinson raised the issue of the email received from Vale of White Horse in respect of a Call for Sites. The Clerk was requested to ask VOWH for specific information on how they would be evaluating suitability of any proposed sites and requesting engagement with the District Council on any sites affecting Sutton Courtenay. This is to be an agenda item going forward.

- (e) The clerk is to write to the Vale of the White Horse to query the rise in the costs of emptying the dog bins.
- (f) Councillor Atkinson is dealing with the application.

(g) Council discussed the correspondence and agreed that there was little that could be done regarding the horses in the field. Councillor Daw raised that the stiles on the land were in a dangerous condition. The clerk is to write to the farmer confirming their state and also mention the horses are found intimidation to some residents whilst writing

Again, it was discussed that little could be done in relation to the land at The Ponds as this was private land and not Parish Council land. The clerk is address the issue in the Sutton Courtenay newsletter requesting people to use caution due to the narrowness of the path.
