Application for a Certificate of Lawfulness for Proposed Use or Development (CLoPUD) to upgrade the existing dewatering bays within the highways maintenance depot as set out in drawing 395020-SKA-HGN-Drayton-DR-CH-0021, used to stockpile material that is collected from highway drainage activities and tipped into existing dewatering bays, as shown on drawing 395020-SKA-HGN-Drayton-DR-CH0020, and stockpiled prior to being disposed of. Enable construction of new concrete bays which are offset further into the depot, compared with the existing and incorporate longer bay walls of precast concrete blocks. In addition, a new, easily maintainable drainage system, including a smart filter chamber, will be installed to ensure all gully waste is contained within the de-watering bay extents. Landscaping will be completed in accordance with proposals approved under permission P17/V0865/CM
